

SENIOR CITIZEN FARE - MHON -

VALID FOR SENIOR CITIZEN 67 OR OLDER WITH ID.
OR - FOR ACCOMPANIED SPOUSE.
OR - FOR BLIND PSGR 16 OR OLDER.
OR - FOR DISABLED PERSON(S) 16 OR OLDER.

NOTE -

VALID FOR DISABLED PASSENGERS 16 OR OLDER WHO RECEIVES PENSION ACCORDING TO THE NORWEGIAN LAW - FOLKETRYGD OF JUNE 17/1966 - OR SIMILAR LAW IN ANY EU COUNTRY.

VALID FOR ESCORT TO A BLIND OR DISABLED PASSENGER.
/THE DISCOUNT IS ONLY APPLICABLE FOR THE PORTIONS TRAVELLING TOGETHER./

VALID FOR STUDENTS ATTENDING SPECIAL SCHOOLS IN NORWAY FOR PEOPLE WITH HEARING PROBLEMS.

NOTE THIS FARES IS NOT APPLICABLE WHEN THE TRAVEL IS PAID FOR BY THE GOVERNMENT AND/OR A SOCIAL SECURITY OFFICE.

NOTE -

PROOF OF AGE /PASSPORT OR OTHER OFFICAL DOCUMENT/
MUST BE PRESENTED AT THE TIME OF TICKETING AND UPON REQUEST AT CHECK-IN.

- SENIORS 67 OR OLDER PROOF OF AGE /PASSPORT OR OTHER OFFICIAL DOCUMENT.
- PASSENGERS UNDER 67 WHO RECEIVE PENSION MUST PROVIDE PROOF OF ELIGIBILITY BY MEANS OF OFFICIAL DOCUMENTATION ACCORDING TO THE NORWEGIAN LAW OF FOLKETRYGD/ KAP 8 /8-3/
- BLIND PASSENGERS MUST PROVIDE PROOF FROM A SOCIAL SECURITY OFFICE AND/OR /NORGES BLINDEFORBUND/
- STUDENTS AGED 16 OR OLDER ATTENDING SPECIAL SCHOOLS IN NORWAY FOR PEOPLE WITH HEARING PROBLEMS MUST PRESENT A STUDENT AND A LETTER FROM THE SOCIAL SECURITY OFFICE STATING THAT THE STUDENT RECEIVING PENSION ACCORDING TO THE NORWEGIAN LAW OF /FOLKETRYGD/.
- PASSENGERS FROM EU COUNTRIES MUST PROVIDE SIMILAR DOCUMENTATION FROM THEIR HOME COUNTRY.
